



## **ATLANTA SAIL & POWER** SOUADRON GICW CRUISE Bv P/D/C Norm Oien, published in D17 Files and Profiles

For the fifth consecutive year, an assemblage of capable and adventurous souls from the fabulous Atlanta Squadron planned a group cruise along a portion of the Atlantic Intra- Friday, 22 June, 2007 coastal Waterway. This year I was extremely fortunate to be a Live-a-boards welcome. Four docks available for docking and part of this impressive and fun-loving group who traveled from Sarasota, FL to Ft Myers and back, a total of 198 joyful miles

The six trailer-boat fleet ranged in length from 21-ft to 27-ft and put in at Sarasota. A 35-ft Bayliner, chartered in Sarasota, and hereafter referred to as "The Mothership", brought the Breakfast on your own. vessel count to seven, with a total crew count of 26.

The fleet departed Sarasota at 0900 Sunday, 29 April, making landfall at Cabbage Key the same day. Docking conditions were horrible, with a 15 mph crosswind adding to the challenge of stern-to docking, but each captain came through with flying colors and the language remained mostly family-friendly. A salute to their seamanship skills!

Monday the fleet eventually arrived at Legacy Harbor in Ft Myers despite some skippers discovering an uncharted bridge and passing under same. Activities included a tour of Thomas Edison's home and museum on the Caloosahatchee River.

Tuesday and Wednesday were spent on Captiva Island, a paradise of bicycle tours, manatee, pelican and heron watching, and relaxing in the finest style. The tidal range and stern-to docking sharpened many skipper's leaping/climbing skill when leaving the vessel. Of course, the evenings were filled with wonderful food, music and dancing.

Thursday's highlight was a stopover at Boca Grande for a fabulous lunch and golf cart tour of the island while taking in history and shopping possibilities. The day ended at Palm Island Resort with a wonderful pool party to while away the Look for the cardboard boat evening hours.

Friday's journey brought us to the Crow's Nest Restaurant in beautiful Venice and then back to Marina Jack's in Sarasota for a final dock party.






## FLARE GUN MALFUNCTION

A defective opening mechanism in some 12-gauge plastic flare guns manufactured by Olin (now Orion Safety Products) prior to 2000 may not open wide enough to accept a flare cartridge. Guns with a odification to correct the possible problem are marketd with U.S. Coast Guard approval code 160 028//12/1. Boaters with older flare guns should check the operation of the opening mechanism now and at the start of each boating season. If the breech will not open wide enough to accept a cartridge, the gun should be snt back for a replacement. Send defective guns to:

(Hint: Dock lines are generally named first by their direction, then by where they fasten to the boat, then by the type of line. All three elements may not be included.)





# POSSIBLE CHANGES TO THE CLEAN WATER ACT

Unless we lobby our Congress and Senate to exempt recreational vessels from the current law, all owners will be required to obtain a National Pollution Discharge Elimination System (NPDES) permit for their vessel. This will not only be a costly effort to obtain the permit, but also will require ongoing monitoring and reporting to ensure compliance.

Currently, the Recreational Boating Act of 2007 is in review in the House (<u>http://a257.g.akamaitech.net/7/257/2422/01jan20071800/</u>edocket.access.gpo.gov/2007/pdf/E7-8738.pdf). Please urge all USPS members to write our elected representatives and request they add this additional legislation to the act to exempt recreational vehicles from this requirement.

The following is an action request from the National Boating Federation.

#### **RE: BOAT BLUE:**

## COALITION ON BALLAST WATER DISCHARGE

Last fall a U.S. District Court ruling nullified EPA Regulation 40 under the Clean Water Act exempting effluent discharge incidental to the normal operation of vessels. The ruling is the result of a lawsuit to halt the introduction of invasive species from ballast water from commercial ships. Unfortunately the ruling did not differentiate between vessels and includes gray water and bilge water discharge from recreational boats as well.(Black water was not mentioned.)

Under the court order, the EPA must establish new regulations and a permit process to enable the normal discharge from recreational boats by September 2008. The permit process and enforcement would be worked out between the EPA and the states.

To fight this ruling and its results, NBF was asked by the NMMA to join the Boat Blue Coalition. The Coalition has informed Congress of the problem and the harm it would do to the marine industry and the boating public. Further, we have cited the need for legislation that would codify the exemption for recreational boats that has existed under the Clean Water Act for many years. This is a significant problem for both manufacturers and the boating public. There are 13 million registered boats in the US and 74 million boaters, contributing to a \$37 billion a year industry.

If the Atlanta Power Squadron were to decide to adopt an official motto, this quote from Kenneth Grahame's *The Wind and the Willows* is a strong candidate for consideration.

But we wouldn't be the first group to think that way. Do a Google search on "messing about in boats", and you'll get over 400,000 hits. Apparently a lot of people agree with the Water Rat's assessment of what constitutes the good life.

I did not know of this quote prior to last summer when a plaque containing these words was affixed at the helm station of my brother-inlaw's new boat. I suppose that points to a deprived, or literarystarved childhood, but nevertheless, I immediately adopted this as a personal credo.

Recently, I encountered the quote embroidered on a decorative pillow in the salon of a friend's boat, and that started me to think about the profound truth captured in this simple sentence.

Why does "simply messing about in boats" hold such strong appeal? The answer probably can be found somewhere in a mixture of escapism and technical competence.

Most serious recreational boaters will quickly agree that there are few things more relaxing than being on the boat cruising, rafted up with friends, or just anchored in a cove – in other words, just messing about. At the same time, most serious boaters recognize the broad range of technical skills required to handle a boat and keep it functioning over time. Besides being able to drive a boat, to navigate a course and find your location, he or she must also be, to some degree, an engine mechanic, an electrician, a plumber, a meteorologist, and a chef.

Boaters are multi-talented people, and messing about in their boats provides an outlet for all those talents.
